Conditions of Competition

Transportation: Players shall walk at all times during the stipulated round, except when permitted to ride by the Rules Committee.

All such requests and required information must be submitted to PGA TOUR no less than 30 days prior to the competition. Please note that requests due to temporary injuries or impairments that do not qualify as a "disability" under the ADA will not be granted.

Caddies: Players are not required to have a caddie; they may carry their clubs.

Golf Carts: Golf carts are not permitted.
